- ORDER THAT: the City of Fitchburg hereby approves the expenditure of funds from the National Council on Aging (NCOA) grant in the approximate amount of \$149,848.73 (ONE HUNDRED FORTY-NINE THOUSAND, EIGHT HUNDRED FORTY-EIGHT AND 73/100 DOLLARS) for the purpose of said grant, which is to increase COVID-19 vaccination rates in MPHN communities and to ensure older adults and people with disabilities get the latest COVID and flu vaccines.

IX. LOAN ORDER

The City of Fitchburg, In the Year 2023

Final Publication of Loan Order 198-22

198-22. LOAN ORDER: That the City appropriate the amount of Four Million, Eight Hundred Thousand Dollars (\$4,800,000.00) for the purpose of paying costs of an Accelerated Repair Project at the Arthur M. Longsjo Middle School, located at 98 Academy Street, Fitchburg, Massachusetts, to replace windows and doors, including the payment of all costs incidental or related thereto (the "Project") which proposed repair project would materially extend the useful life of the school and preserve an asset that otherwise is capable of supporting the required educational program, and for which the City may be eligible for a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction of the School Committee. To meet this appropriation the City Treasurer, with the approval of the Mayor, is authorized to borrow said amount under M.G.L. Chapter 44, or pursuant to any other enabling authority. The City acknowledges that the MSBA's grant program is non-entitlement, discretionary program based on need, as determined by the MSBA, and , if the MSBA's Board of Directors vote to invite the City to collaborate with the MSBA on this proposed repair project, any project costs the City incurs in excess of any grant that may be approved by and received from the MSBA shall be sole responsibility of the City; provided that any grant the City may receive from the MSBA for the Project shall not exceed the lesser of (1) eighty percent (80%) of eligible approved project costs, as determined by the MSBA, or (2) the total maximum grant amount determined by the MSBA;

and that the amount of borrowing authorized pursuant to this vote shall be reduced by any grant amount set forth in the Project Funding Agreement that may be executed between the City and the MSBA. The Treasurer is authorized to file an application with the Municipal Finance Oversight Board to qualify under M.G.L. Chapter 44A any or all of the bonds authorized by this order and to provide such information and execute such documents as the Municipal Finance Oversight Board may require for these purposes.

Bond Counsel recommended that the City republish that loan order in full for at least 10 days, which was advertised on March 22, 2023, and have the City Council re-vote to approve the order. Third and final reading on Loan Order 198-22 by roll call vote of 11 in favor and 0 opposed. 11 members present. Board consists of 11 members.

X. ORDINANCES

O36-23. BE IT ORDAINED THAT - The following be added to Chapter 3 of the Fitchburg City Code:

3-19A Flags to be Flown

In addition to the flags of the United States of America, the Commonwealth of Massachusetts, and the City of Fitchburg, other flags shall not be flown on City flagpoles or otherwise displayed in official fashion on City property, except as permitted by the subsequent paragraph, unless authorized by a resolution approved by a majority vote of the City Council, affirming that such flag will stand as an expression of the official sentiments of the City of Fitchburg. The City's flagpoles and other facilities are not designated as a forum for expression by the public.

If, due to unforeseen or sudden circumstances, the expression of official sentiments through the raising of a flag would be unduly hindered by delaying until the next scheduled City Council meeting, the Mayor may communicate a proposed resolution pursuant to the preceding paragraph directly to all members of the City Council and the City Clerk, along with a thorough explanation of the asserted urgency. If, after forty-eight (48) hours no objection is raised by a City Councilor, that flag may be raised and the resolution included as a Communication from the Mayor at the following meeting of the City Council. If any Councilor raises an objection in writing, the flag in question shall not be flown until the City Council has approved the proposed resolution.

Mayoral Veto

Mayor DiNatale read into record communication of the Veto.

Councilor Van Hazinga stated this is an issue due to Boston, the City of Fitchburg wants to use the Flag poles for Government Speech. Best way for government speech, not a public forum for speech, have it through a legislative process, not an executive process, which is made in private by one person. The Mayor has updated his policy to include the legislative in the process. Anything by executive order can be changed. One when person is in control in deciding what the government speech is it creates problems. If our public facilities and flag poles are going to be used for public speech there needs to be a process and it should be a legislative process.

President Zarrella appreciates the Mayors update to the policy, however the issue under the current policy the Council can say yes, but cannot say no. If the mayor wants to convey his own thoughts, it is an issue of comity, a city as whole has to be speaking in unison, the City itself should not be convey a message the Council is not conformable with.

Councilor Fleming did not have any constituents in her ward reach out to her on the Flag discussions. We need to keep the City moving forward.

Councilor Green does not want this to me a morale debate or pitting ourselves against colleagues or residents as a whole. Supports the Mayor in his decisions, does not want to start overruling his decisions.

Councilor Cragin was glad to see the revisions in the order from the Mayor. Glad to see the update to section D and the Parks and Recreations. Is happy with the revision with this letter.

Councilor Schultz thinks the updated executive order is more detailed than the first one, does agree that the Executive order can be changed at any time. Come with an Ordinance not just an Executive Order, which would require more input from the Mayor.

Councilor DiNatale does not want to get involved with every flag request. To be fair and consistent, I will not vote for any flag as a member of this council. The council will be branded by every flag they approve or deny. The executive order states that City Council will still vote on the flags, I do not want the discord within this Council. All the other organizations' are out there waiting for us to say no, so they can litigate against the City.

Councilor Zarrella clarified any three residents already have the right to bring any petition to Council. This is not about this Mayor, I would not be comfortable with any Mayor to having that unilateral power. Government is a State entity, we can promote a particular policy on behalf of the City. The voice of the Government as an entity, is deictic from the voice of community as a collective of 40,000 people.

Councilor Couture requested move to vote on Ordinance 036-23, President clarify that a yes vote would uphold the Ordinance and No vote would allow a Veto to stand. By roll call vote of 5 in favor and 6 opposed (Councilors Schultz, Couture, Cragin, DiNatale, Fleming and Green) veto stands. 11 members present. Board consists of 11 members.

Councilor DiNatale recused himself at 8:09 P.M.

092-23. BE IT ORDAINED THAT – Chapter 3, Article IV, section 3-43 O. shall be amended as follows by adding to the end:

Attached to said petition shall be a communication from the City Auditor indicating what each salary would be if increased by the "CPI Adjustment Factor" as defined below, which communication shall be read out or summarized by the Chair at any session in which the Council or a subcommittee thereof debates or votes on such petition. For the purposes of this subsection, the CPI Adjustment Factor shall be defined as the lesser of five percent (5%) or the result of the following calculation: [(CPI-U for January of the then current year minus the January CPI-U for the preceding year) divided by the previous year's January CPI-U] multiplied by 100 equals the CPI Adjustment Factor. But in no case shall the CPI Adjustment Factor be less than zero percent (0%). CPI-U shall mean the Consumer Price Index Boston-Cambridge-Newton MA-NH (1982-84 = 100) as published by the New England Information Office of the U.S. Bureau of Labor Statistics. (www.bls.gov/regions/new-england/data/ConsumerPriceIndex_Boston_Table.htm). After a review of the proposed increase the City Council shall then vote on the Mayor's salary and the City Councilors' salary.

President Zarrella recommends referring Ordinances 090-23 through 092-23 to Legislative Affairs. Councilor DiNatale returned at 8:10 P.M.

(Suspension of Rules)

President Zarrella informed the council this is a technical item. There was a practice for over 30 years, which the Fitchburg Retirement System treated employee's vacation and personal leave buyback amounts as regular compensation. In 2018 a State Board issued a decision causing the Retirement Board to stop treating employee vacation and personal leave buybacks as compensation. In 2022 the State passed a statue to restore vacation time, however the State did not include the personal leave. The State recommended filing this Home Rule Petition to fulfill our promise to include personal leave buyback in the retirement benefits.

Anna Farrell, stated the all councilors received a letter, if you have a questions we are happy to answer them.

Councilor Squailia confirmed personal buyback is from 2018 and back. She asked to explain why the stop in personal leave.

Mr. Dateo Jr, shared that the State Legislative passed a law that vacation time be a sellable buyback, they did not include personal leave. The Retirement Board had allowed both for over 30 years, the money was taken out of Fitchburg employees and included both, the law only include vacation, we are asking for buyback for both vacation and personal leave.

Councilor Squailia asked what Fitchburg does differently than other communities with personal leave.

Mr. Dateo Jr, explained the employees in Fitchburg earn personal days, other committees give a specific amount each year.

Councilor Squailia asked about the funding of this.

Mr. Dateo Jr. explained that the employees have already been putting the money in the system. The time is already in the system and paid for. We are trying to honor the union contracts and get the employees their earned personal leave. Every employee prior to May 1, 2018, had already sold back time their time, the retirement board had taken a certain amount of their pay. Employees have been doing this for decades.

Councilor Green shared this is earned personal leave, the employees have been waiting for 4.5 years for this to be resolved and supports this petition moving forward.

Motion to suspend the rules by roll call vote of 11 in favor and 0 opposed. 11 members present. Board consists of 11 members.
